## PRIVACY STATEMENT HET MEISJE IN BLAUW

Your privacy is important to Het Meisje In Blauw. In this privacy statement, we explain what personal information we collect when you use our services, why we need this information and how we use it. We attach great importance to the protection, confidentiality and integrity of your personal data.

We would also like to inform you about your rights.

### 1. Responsibility for your data

### 2. Personal data that we process

Het Meisje In Blauw processes your personal data by using our services and / or by providing it to us yourself.

Below is an overview of the *personal data* we process:

- First and last names
- Residence address
- Telephone numbers
- E-mail address
- Date of birth
- Bank account number
- Wedding date

Special and / or sensitive personal data we process:

Het Meisje In Blauw processes the following special and / or sensitive personal data of you:

- Sexual preference (f.e. gay marriage)
- Religion (f.e. if the church is married)
- Ethnic background
- Health (f.e. if this affects the execution of the agreement)

### 3. For what purpose and on the basis of which we process personal data:

Het Meisje In Blauw processes your personal data for the following purposes:

- Handling your payment.
- To call or e-mail you if necessary to carry out our services.
- To be able to perform the services properly as agreed.
- To comply with legal obligations, such as keeping an administration.

### 4. Sharing your personal data with third parties:

Het Meisje In Blauw will not sell your information to third parties and will only provide this information if this is necessary for the execution of our agreement with you or to comply with a legal obligation. With companies that process your data in our assignment, we conclude a processor agreement to ensure the same level of security and confidentiality of your data. Het Meisje In Blauw will remain responsible for these processing operations.

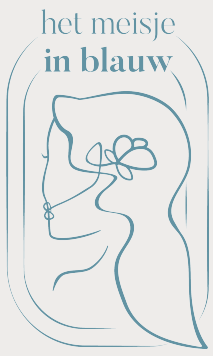
Where are your data stored even more:

### 5. How long we keep your personal data:

Het Meisje In Blauw does not store your personal data longer than is strictly necessary to realize the goals for which your data is collected. We use the following retention periods for the following (categories) of personal data:

- Name and Bank account number> Retention period: 7 years after sending the last invoice> Reason: legal obligation
- Special personal data & Date of birth> Retention period: 4 years after concluding the contract> Reason: for the proper execution of the agreed services.

#### **6. Cookies, or similar techniques, that we use**

Het Meisje In Blauw uses cookies on her website. The use of cookies on the website of Het Meisje In Blauw is exclusively intended for the technical functionality of the website. This means that the website is working properly, optimized and your preferred settings are remembered

#### **7. View, modify or delete data**

You have the right to view, correct or delete your personal data. You also have the right to withdraw your consent to the data processing or to object to the processing of your personal data by Het Meisje In Blauw and you have the right to data portability. This means that you can submit a request to us to send the personal information we have in your computer file to you or another organization mentioned by you.

You can send a request for access, correction, deletion, transfer of data from your personal data or request for cancellation of your consent or objection to the processing of your personal data to [vivian@hetbruidmeisje.nl](mailto:vivian@hetbruidmeisje.nl).

To ensure that the request for access has been made by you, we ask you to send a copy of your ID with the request. Make your passport photo, MRZ (machine readable zone, the strip with numbers at the bottom of the passport), passport number and citizen service number (BSN) black in this copy. This is to protect your privacy. We respond as quickly as possible, but within four weeks, at your request. Het Meisje In Blauw also wishes to point out that you have the opportunity to file a complaint with the national supervisory authority, the Dutch Data Protection Authority. #### **8. How we protect personal data**

Het Meisje In Blauw takes the protection of your data seriously and takes appropriate measures to prevent misuse, loss, unauthorized access, unwanted disclosure and unauthorized modification. #### **9. Automated decision-making**
